Previously Opening Permission has been accorded for Classes I to V for the year 2018-2019 in Proceedings L.Dis.No.3541-E4/2019, dt.07-05-2019 of the District Educational Officer, East Godavari, Kakinada. The Correspondent has submitted the application for provisional Recognition for Classes I to V in the school for the years from 2018-2019 to 2027-2028 in the letter reference 4<sup>th</sup> cited. The Mandal Educational Officer, Korukonda has verified the application for provisional recognition with reference to the conditions laid down in the permission orders and G.O.Ms.No.1 Edn. Dept. dated 01-01-1994, G.O.Ms.No.41 Edn. Dept. dated 11-05-2006 and G.O.Ms.No.74 Edn. Dept. dated 11-09-2006 and recommended to accord provisional recognition from 2018-2019 to 2027-2028. The District Educational Officer, East Godavari, Kakinada is hereby accords provisional recognition for a period of **Ten (10)** years commencing from the academic year from 2018-2019 to 2027-2028 for classes I to V (English Medium) subject to the fulfillment of the following conditions in respect of Laurel High School (EM), Gadala, Korukonda Mandal.

3. That the institution shall adopt the curriculum and syllabus prescribed by government from time to time.
4. That the school timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by the Government employees shall be appointed as per the staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
8. That the list of Governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure or fee structure fixed by the governing body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with.
11. that the school shall not be closed without giving notice both to the parents, District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposals for renewal of recognition sufficiently in advanced (i.e) at least six months prior to the date of the present recognition.
14. All the appointments should be regulated as per norms stipulated in G.O.Ms.No.1 Edn. Dept. dated 01-01-1994.
15. Other conditions as per G.O.Ms.No.1 Edn. Dept. dated 01-01-1994, G.O.Ms.No.41 Edn. Dept. dated 11-05-2006 and G.O.Ms.No.74 Edn. Dept. dated 11-09-2006 should be followed from time to time.
16. Economic strength should be maintained for all classes.

The Correspondent is hereby informed that the undersigned is vested powers to withdraw the recognition now accorded if there is any deviation or false information or non fulfillment of conditions as per rules in force without any notice in future will be withdrawn.

The Correspondent has submitted the application for Provisional Recognition for the classes VI to X (E.M) in the school for the years from 2018-19 to 2027-2028 through the Deputy Educational Officer, Rajamahendravaram in the reference 7<sup>th</sup> read above. The District Educational Officer, East Godavari, Kakinada has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada is Competent authority for Secondary Schools hereby grants **Provisional Recognition** for a period of **10 (TEN)** years i.e., for the academic years from **2018-2019 to 2027-2028** for the classes **VI to X (EM)** as recommended by the Deputy Educational Officer, Rajamahendravaram and the District Educational Officer, East Godavari, Kakinada, subject to fulfillment of the following conditions **Laurel High School (EM), Gadala, Korukonda Mandal, East Godavari District**.

5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern .
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
20. The school shall have first aid kit and the teachers shall be trained in first aid
21. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that the there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail
23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the management has to maintain trained teachers at all time
25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. Further, the management is informed to follow the rules and regulations prescribed in Cir. Memo.No.21748/D1/97, dt.16-2-1998 and other orders of Transport Authority regarding parking of school vehicles /maintenance of vehicles and ensure safety of children, and shall obtain fitness of the school vehicles from the Transport Authorities as prescribed by the Government from time to time.
27. That the Management shall confirm the soundness of the building by the EE, R&B/PR concerned and submit the same through the Inspecting Officer concerned without fail.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed. Receipt of these proceedings should be acknowledged.
